In January the Board held its annual retreat. Themes of the meeting included:

#### **Future Meetings**

- A special meeting to honor long-time MGO members.
- An endorsement meeting for the upcoming state special election.
- Discussion of new city administrator who will be place later in the spring.

Other possible meeting topics include: Mayor Quan's call for Oakland citizen volunteers; Oakland's Image; city

and state budgets; the City's Community and Economic and Development Agency (CEDA); Public Employee pensions; City maintenance issues including street sweeping, park maintenance, and road maintenance; new Oakland Athletics stadium proposals; the City Attorney's Office gang injunctions, and impact of underwater mortgages in the greater Oakland Area.

#### **Membership**

The Board discussed both recruiting new MGO members, and getting more involvement from the current membership. We would like your feedback on topics that you would like to debate, and events that you'd like to see. Next month's Platform will include a survey to better receive your input.

#### Oakland Schools Truancy

For the last two years truancy has been a major MGO issue: We have had speakers from the Oakland Unified School District and the Truancy Court. Board members participated in city meetings focused on truancy. Truancy is a huge issue here in Oakland, and while school attendance greatly affects each student's future, truancy rates also directly correlate with crime statistics and general City welfare.

Oakland schools put much effort into lowering truancy rates, and have had some success. School funding levels depend on average school attendance which provides additional motivation to address the issue. Our students need more people who are willing to give time to work with students as tutors,,,coaches, or other school volunteers.

### MGO'S LOCAL GOVERNMENT ACCOUNTABILITY TASK FORCE: OUR CONTINUING FOCUS

Many of you know that over the last year and a half MGO has emphasized local government in the City of Oakland and Alameda County. We have done this by actions of our Local Government Accountability Task Force.

The Task Force identifies issues for MGO to address, gains support from the general membership, and then lobbies, speaks at government meetings, writes letters or meets with elected officials to present our views, concerns and recommendations.

Under this Task Force, we have supported the City Council's measures to cut down on nepotism in hiring and promoting in City government.

We've looked at the Pay-Go funds provided to each Councilmember for discretionary spending in his/her

district, to determine if this is best use of City money and if the funds were used for expenditures which might not have been approved by the full Council.

We've investigated the operations of the Measure Y Oversight Committee, and the way the City Council addressed the findings of that committee to improve the operations of the Measure Y violence prevention groups.

We've looked at the qualifications and limitations put on members of the Public Ethics Commission as it relates to persons having direct family or financial ties to lobbyists, since the PEC is the group which regulates lobbyists.
